The Insurance Business (Bailiwick of Guernsey) Law, 2002, as amended (Insurance Law)

1. NOTICE is hereby given pursuant to Section 44 of the Insurance Law that:

the Transferor and the Transferee intend to apply to the Royal Court of Guernsey (**Royal Court**) for the sanction pursuant to Section 44 of the Insurance Law by the Royal Court of Guernsey a scheme (**Scheme**) providing for the transfer to the Transferee of the entire long term insurance business of the Transferor, including in respect of Guernsey resident policyholders;

- 2. the Transferor and the Transferee have made copies of:
 - a) the proposed application;

Any person (including any employee of the Transferor or the Transferee) who alleges that he would be adversely affected by the carrying out of the Scheme is entitled to be heard by the Royal Court at that hearing.
