**The Insurance Business (Bailiwick of Guernsey) Law, 2002, as amended  
(Insurance Law)**

**Aviva Annuity UK Limited (Transferor)**

**Aviva Life & Pensions UK Limited (Transferee)**

1. NOTICE is hereby given pursuant to Section 44 of the Insurance Law that:

the Transferor and the Transferee intend to apply to the Royal Court of Guernsey (**Royal Court**) for the sanction pursuant to Section 44 of the Insurance Law by the Royal Court of Guernsey a scheme (**Scheme**) providing for the transfer to the Transferee of the entire long term insurance business of the Transferor, including in respect of Guernsey resident policyholders;

2. the Transferor and the Transferee have made copies of:

- a) the proposed application; and
- b) the report of an independent actuary (**IA Report**)

available for inspection (or collection) at all reasonable times at the office of Appleby (Guernsey) LLP at the address given below up to and including the date of the court hearing. 3. the application to sanction the Scheme is due to be heard by the Royal Court at The Royal Court House, St Peter Port, Guernsey GY1 2NZ on 16 December 2016 at 9.30am.
4. Any person (including any employee of the Transferor or the Transferee) who alleges that he would be adversely affected by the carrying out of the Scheme is entitled to be heard by the Royal Court. If you intend to appear at the hearing before the Royal Court, you are requested to give notice of your intention to do so to Aviva in writing to the Aviva PO Box referred to above by 6 December 2016.
