**54/2017** Approach to Consultancy/Terms of Reference – Report dated 25<sup>th</sup> April 2017 tabled and noted.

The Policy & Finance Committee agreed that:-

- 1. In the interests of obtaining value-for money from consultants:
- All consultancies should, where practical, and unless otherwise agreed by the relevant Committee, be commissioned in accordance with the previously agreed process to demonstrate competiveness and value for money;
- The Chief Executive and Treasurer to have delegated authority to agree expenditure up to £25,000 as previously agreed (Mr Snowdon, Mr Dean & Mr Jean against);
- Every appointment should have clear Terms of Reference with agreed outcomes, and these to be available to the relevant Committee at all times.
- In all but exceptional cases invitations for consultancy work should be advertised in Alderney.
- Where voluntary on-island support was being considered, that it should still be subject to the same assessment criteria in terms of quality and performance.

- 2. In the interest of good governance and transparency and in common with disclosure practices in other jurisdictions, clauses should be incorporated into consultancy agreements, in all but exceptional circumstances entitling the SoA to make public:-
- The name of the entity providing the consultancy service;
- The total value or budget of the consultancy appointment including expenses.

This should not extend to disclosure of tender prices or day rates.

**56.2** Regulation of Postal & Electricity Services - Letter from Peter Ferbrache dated 13<sup>th</sup> April 2017 tabled and noted. The Committee stated that a short time frame for comments/approval appeared to be a regular expectation. Matter of response times to be raised at the next ALG meeting. Noted.

#### **56.3** Article **50** & Protocol **3** – Report tabled and noted.

The Policy & Finance Committee agreed to:-

- Note that Her Majesty's Government has issued a notice under Article 50 of the Treaty on European Union.
- Note and recognise the subsequent impact this and the withdrawal of the United Kingdom from the European Union will have on the Bailiwick's domestic legislation and that the legislative and other measures that will need to be taken in consequence of the issue of the notice and withdrawal.
- Note that Alderney will continue: to represent Alderney's interests; to engage
  with the other islands in the Bailiwick of Guernsey, and, as appropriate, to
  engage with the UK as the Brexit process unfolds and negotiations begin.
- Agree that a in-house review be carried out to assess whether the opportunity should be taken to amend or repeal certain pieces of legislation, such as the Loi relative à l'acquisition de Propriété Immobilière en cette Île par des

Étrangers ou par des Sociétés Étrangères, 1906, to assess whether these remain necessary in this day and age.

**56.4** <u>Hawkers Licence</u> – Report from Treasury dated 20<sup>th</sup> April 2017 tabled and noted. The Policy & Finance Committee agreed by majority (Mr Jean and Mr Dean against) to issue the licence subject to standard trading conditions as per other units, and to include conditions relating to trade in the Harbour and Campsite area.
