NOTICE IS HEREBY GIVEN that on 24th July 2017 AXA Wealth Limited ("**AWL**") and Phoenix Life Limited ("**Phoenix**") applied to the High Court of Justice of England and Wales, pursuant to section 107(1) of the Financial Services and Markets Act 2000 (the "**Act**"), for an Order under section 111 of the Act sanctioning a scheme (the "**Scheme**") for the transfer to Phoenix of the entire business of AWL (the "**Business**") and for the making of ancillary provisions in connection with the implementation of the Scheme under sections

The proposed transfer will result in the Business which is currently carried on by AWL being carried on by Phoenix. Under the terms of the Scheme, all liabilities in respect of the Business as at the date of transfer shall be transferred to and become liabilities of Phoenix. All claims in respect of the policies comprised within the Business shall, upon the transfer becoming effective, be dealt with by Phoenix.

Any person intending to attend is requested to give notice of such intention as soon as possible and preferably before 31 October 2017, setting out their grounds of objection or how they may be adversely affected, either to AWL or Phoenix by calling the number above or by writing to the address above, or by writing to the solicitors named below.
