Item IV **The Data Protection (Bailiwick of Guernsey) Law, 2017**

The following amendment was received from Mr Dent, seconded by Mr Dean

“I propose that the revised version of the Data Protection (Bailiwick of Guernsey) Law, 2017 as amended and approved by the States of Deliberation on 29th November 2017 be substituted for the version currently appended to the Billet d’Etat for Wednesday 6th December 2017.

The proposition will remain unchanged:

The States of Alderney is asked to approve the Project de Loi entitled “The Data Protection (Bailiwick of Guernsey) Law, 2017”, and to authorise the Bailiff to present a most humble petition to Her Majesty in Council praying for Her Royal Sanction thereto.”
