## NOTICE

NOTICE IS HEREBY GIVEN that, under section 68 of the Income Tax (Guernsey) Law, 1975, as amended, every person, whether or not liable to pay any tax, who has notified the Director of Income Tax that they are chargeable to tax, is required to deliver a return of their income for the calendar year 2017, by 30<sup>th</sup> November 2018 unless:

- the Director has notified the person, separately, in writing, that they need not do so, and
- the conditions under which such notification was given have continued to be satisfied throughout 2017.

Companies are required to submit their 2017 return online. Individuals may also submit their 2017 return online unless they choose to do so in paper form. The personal and company online returns may be accessed at <https://eforms.gov.gg/>. Personal paper returns may be obtained from the States Office and can also be downloaded from [www.gov.gg/tax](http://www.gov.gg/tax) under "Income tax returns" with effect from 2<sup>nd</sup> January 2018.

Penalties may be imposed if the return is not received by the due date.

If a person has not notified the Director that they are chargeable to income tax, they must do so by 14<sup>th</sup> July in the year following the first year they became so chargeable. Penalties may be imposed if such notification is not received within the required timeframe.
