**The Alderney Road Traffic and Public Highways Ordinance, 1966  
(Overhanging vegetation on public highways)**

Section 30 (1) of the above ordinance refers to overhanging vegetation on public highways so as to endanger pedestrians or obstruct vehicles (or interfere with the view of drivers).

All residents/homeowners are asked to please ensure that there is no vegetation from their property overhanging the road and to take immediate measures for its removal if it exists, especially now that it is the busy season and there are more visitors on island. Failure to do so is an offence and could lead to prosecution.

**The Noxious Weeds Law (Amendment) (Alderney) Ordinance 2003**

In November 2003 the States passed the above Ordinance which reduced the Schedule under the Noxious Weeds Law (Loi Relative aux Mauvais Herbes 1933) to one species, namely **Common Ragwort**.

The aim was to target this one specific weed and bring it under control.

All owners and tenants of land are requested to take action to remove as soon as possible any Ragwort found on their land. Failure to do so is an offence and could lead to prosecution under the Law.
