NOMINATIONS

By Election – Nominations of qualified persons who wish to offer themselves for election as a Member of the States of Alderney for a 2 year period of office must be submitted to the Chief Executive at the States Offices during the 7-day period ending:-

Thursday, 6th December 2018
The nomination list will close at 1600 hours (4.00p.m.) on that day.

Plebiscite - All States Members continuing in office and those successfully elected on the 1st December 2018, who would like to put their name forward to be an Alderney Representative in the States of Guernsey, must submit a nomination form* to the Chief Executive at the States offices during the 7-day period ending:-

Thursday, 6th December 2018
The nomination list will close at 1600 hours (4.00p.m.) on that day.

ABSENT VOTERS

Residents on the Electoral Roll are reminded that should you be absent from the Island on Election Day, and you wish to vote, there are two alternatives open to you –

(1) **Postal Vote** – Application forms can be obtained from the office of the Chief Executive. However, it should be remembered that voting slips cannot be posted to you until they have been printed following closure of the nomination process.

(2) **Proxy Vote** – Application forms can be obtained from the office of the Chief Executive. You may nominate a relative or friend to cast a vote on your behalf on Election Day.

Applications for both postal and proxy voting must be registered with the Chief Executive at least two days prior to the election.
