UPON the application dated 30 November 2018 heard on 5 December 2018 (the "**Application**") pursuant to Section 44 of the Insurance Business (Bailiwick of Guernsey) Law, 2002 (the "**Law**") for the sanction of the Guernsey Scheme attached hereto for the transfer to Utmost Ireland Designated Activity Company (the "**Transferee**") of certain policies of Athora Ireland Public Limited Company (the "**Transferor**")

AND UPON hearing Advocate Friedlaender, Counsel for the Applicants

AND UPON calling for opposition, in the absence of any opposition being noted

AND UPON reading the first affidavit of Tadhg Clandillon sworn on 25 September 2018 and the second affidavit of Tadhg Clandillon sworn on 28 November 2018 and other affidavits filed of record

AND IT APPEARING that the Application was accompanied by a report on the terms of the Guernsey Scheme by an independent actuary, Rosemary Commons, a Fellow of the Society of Actuaries in Ireland and a consulting actuary at Willis Towers Watson (Ireland) Limited dated 12 July 2018 as well as a supplementary report by the independent actuary dated 21 November 2018 (the "Independent Expert's Reports")

AND IT APPEARING that the notice required by Section 45(3)(a) and Section 101(1) of the Law (the "**Notice**") has been duly published in accordance with the terms of Section 45(3)(d) of the Law

AND IT APPEARING that a statement (the "**Policyholder Pack**") has been dispatched to Guernsey Transferring Policyholders in accordance with Section 45(3)(b) of the Law and as specified by the Guernsey Financial Services Commission (the "**Commission**") in its letter dated 10 August 2018

AND IT APPEARING that a copy of the Application, the Independent Expert's Reports and the Guernsey Pensions Policyholder Pack have been served on the Commission pursuant to Section 45(3)(c) of the Law

AND IT APPEARING that copies of the Application and of the Independent Expert's Report of 12 July 2018 have been available for inspection by policyholders or their proxies at an address in Guernsey set out in the Notice throughout the period since the Notice was last published and that copies of the said Independent Expert's Report have been available for collection there during that period

AND IT APPEARING that certain minor amendments have been made to the Irish Scheme which forms the Appendix to the Guernsey Scheme but that no amendments have been made to the Guernsey Scheme

AND UPON READING a letter from the Commission dated 27 November 2018 and upon the Court being satisfied pursuant to Section 46(a)(ii) of the Law that the Transferee is licensed to carry on insurance business of the descriptions concerned in Ireland being the country outside the Bailiwick where the Transferee is to undertake its obligations under the policies to be transferred to it

AND IT APPEARING from the letter from the Commission dated 27 November 2018 that the Commission has certified in accordance with Section 46(b)(ii) of the Law that the Central Bank of Ireland (being the "relevant supervisory authority in the country concerned") have been notified of the Guernsey Scheme by the Commission and have not refused consent to the transfer

AND UPON the Transferor and the Transferee by their Counsel undertaking to be bound by the Guernsey Scheme hereinafter sanctioned and to execute all such documents and do all such acts and things as may be necessary or expedient to be executed or done by them for the purposes of giving effect to the Guernsey Scheme

AND IT IS ORDERED THAT pursuant to Section 48 of the Law (definitions are as set out in the Guernsey Scheme), on and with effect from the Guernsey Effective Date, the Transferring Guernsey Business and Residual Guernsey Assets and the Residual Guernsey Liabilities shall be transferred to and be vested in the Transferee in accordance with the Guernsey Scheme by this order and without any further act or instrument.

AND IT IS FURTHER ORDERED that the Transferor and the Transferee shall, within a period of 10 days from the date of this Order, or such longer period as the Commission may allow, deposit an office copy of the Order with the Commission.

AND IT IS FURTHER ORDERED THAT notice of the making of this Order shall be published once in La Gazette Officielle, the Alderney Gazette and the Sark Notice Box.

AND IT IS FURTHER ORDERED THAT the Transferor and the Transferee shall have liberty to apply to the Court for the purposes of Section 44 of the Law and generally.
