Application pursuant to Section 44 of The Insurance Business (Bailiwick of Guernsey) Law, 2002, as amended (the "**Insurance Law**").

Notice is hereby given pursuant to Section 45(3)(a) of the Insurance Law that:

1. Zurich Assurance Ltd ("**ZAL**") and Scottish Widows Limited ("**SWL**") intend to apply to the Royal Court of Guernsey for sanction pursuant to Section 44 of the Insurance Law of a scheme providing for the transfer from ZAL to SWL of certain long term insurance business in respect of policies in that business issued to persons resident in the Bailiwick of Guernsey (the "**Scheme**").
2. Copies of:
 - (a) the proposed application; and
 - (b) the report on the terms of the Scheme prepared by an independent actuary (the "**Report**"),

4. The application to sanction the Scheme is due to be heard by the Royal Court of Guernsey at The Royal Court House, St Peter Port, Guernsey on 21 June 2019 at 9:30 am (the "**Court Hearing**").
5. Any person (including any policyholder or employee of ZAL or SWL) who alleges that he or she may be adversely affected by the carrying out of the Scheme has a right to attend the Court Hearing and express their views, either in person or by legal representative. It would be helpful if any person intending to attend the Court Hearing gives notice of such intention as soon as possible and preferably before 3 June 2019, setting out the reasons why they believe they may be adversely affected, either to ZAL or SWL by calling the relevant number above or writing to the relevant address above, or by writing to Collas Crill LLP quoting the reference noted below. This will enable ZAL and SWL to provide notification of any changes to the Court Hearing and, where possible, to address any concerns raised in advance of the Court Hearing.
