NOTICE is hereby given pursuant to section 45(3) of the Insurance Law that the Parties intend to apply to the Royal Court of Guernsey (the "**Court**") on 26 June 2020 at 10.15 am (the "**Application**") for an order under section 44 of the Insurance Law sanctioning a scheme (the "**Transfer**") providing for the transfer to MLIDAC of the whole of the insurance business of MIDAC and MADAC in respect of Guernsey resident policyholders.

Copies of the Application and a report on the terms of the transfer prepared by an independent actuary pursuant to section 45(2)(a) of the Insurance Law (the "**Transfer Report**") are available for inspection (and in case of the Transfer Report, for collection) during office hours at the offices of Bedell Cristin Guernsey Partnership at the address below. In addition, copies of the Transfer Report may be obtained free of charge by writing to Barclays Policy Administration Department, c/o Monument Life Insurance DAC, 50 Kings Hill Avenue, West Malling, Kent, ME19 4JX or by telephone on 0800 422 0119 for Barclays Policyholders or 0800 422 0129 for Barclaycard Policyholders, Monday to Friday (except public holidays) during normal business hours, from the date of publication of this notice until the date on which the Court is asked to sanction the Transfer. These documents and other related documents are available on the Monument Re Group website at www.monumentregroup.com.

The Application is due to be heard at the Royal Court of Guernsey, St Peter Port, Guernsey on 26 June 2020 at 10.15 am. Any person who thinks that he or she would be adversely affected by the carrying out of the Transfer may attend the hearing and oppose the Application, either in person or by Counsel. Anyone intending to do so is asked to inform MADAC, MIDAC or MLIDAC (as appropriate) at the address provided above as soon as possible and preferably before 15 June 2020 setting out his grounds for objection and to give not less than two clear days' prior notice in writing of such intention and the reasons therefore to Bedell Cristin Guernsey Partnership at the address set out below. This will enable MADAC, MIDAC or MLIDAC (as appropriate) to provide notification of any changes to the hearing and, where possible, to address any concerns raised in advance of the hearing.

Any person who objects to the Transfer but does not intend to attend the hearing may make representations about the Transfer by giving written notice of such representations to MADAC, MIDAC or MLIDAC (as appropriate) in writing as soon as possible and preferably before 15 June 2020.

MADAC, MIDAC or MLIDAC (as appropriate) will inform the Guernsey Financial Services Commission of any objections raised in advance of the hearing, regardless of whether the person making the objection intends to attend the hearing.
