Item I **The Speed Trials (Alderney) Ordinance, 2013**

Item III **Changes to the Council Regulations of the EU Sanctions Regime**

The States resolved to approve:-

- 1. “The Iran (Restrictive Measures)(Alderney) (Amendment) Ordinance, 2013”;**
- 2. “The Tunisia (Freezing of Funds) (Alderney) (Amendment) Ordinance, 2013”; and**

3. "The Egypt (Freezing of Funds) (Alderney) (Amendment) Ordinance, 2013".

Item IV **Building and Development Control Committee Members**

The States resolved to appoint:-
