The reductions in flights and aircraft have restricted the number of reduced price seats available through advanced bookings. Yet, Aurigny is operating with aircraft suffering more frequent breakdown. The quality of air services has left Alderney abandoned and vulnerable. People cannot afford the ever spiralling fare structures. Confidence and investment in the economy is very weak.

The Island's economy is in ruins and heading for catastrophe unless States Members act to halt the decline.

House prices have declined by as much as 50% since the highs of 2007 and half the younger working generation, those in the age group 20-35 have left the Island to seek work and prosperity elsewhere, predominantly in the UK mainland.
