Item 1 Alderney Potable Water Project - Phase 3 Replacement Water Storage Project at La Marette

The following amendment to the Alderney Potable Water Project Phase 3 Replacement Water Storage Project at La Marette was proposed by Mr Beaman and seconded by Mr Tugby.

"In proposal 2 of item 1:

Delete the figure £465,000 and replace with £420,000

Amendment carried.

The proposition as amended was then voted upon.

- 2. Accept the total expenditure of up to £420,000 to implement the Phase Three of the Potable Water Project.**
- 3. Delegate the Policy and Finance Committee to approve the method of funding for the project, following discussions with the Treasury and Resource Department.**
