

# An Introduction to Alderney

Alderney, the third largest of the Channel Islands, lies just 8 miles off the Normandy coast of France and is the nearest to the mainland of Britain. Yet, despite its closeness to France and the UK, the inhabitants of this charming and tranquil island enjoy an enviable laid-back lifestyle and unique quality of life.


Alderney has owed allegiance to the English crown for over 900 years. The island is outside the EU and is also a British off-shore tax alternative to the larger islands. Alderney has its own independent judiciary, a stable government and boasts a well-balanced economy generated by its fledgling offshore finance industry, its rapidly growing e-commerce and e-gaming sectors and its traditional tourism and fishing industries.

Alderney is just 3½ miles (5km) long and 1½ miles (3km) at its widest point. The island's permanent population of 2,400 people is composed of indigenous islanders and British as well as cosmopolitan settlers who have found it easy to integrate into this small society of friendly, welcoming and interesting people.

Alderney has a great deal to offer, including a quiet, relaxing lifestyle amidst beautiful surroundings and a generally warmer climate than that of the UK.

The island has a small, well managed airport with three operational runways and handles over 70,000 passengers a year arriving by scheduled or charter flights from Southampton, Guernsey, Jersey (via Guernsey), or by private aircraft from the UK and the Continent.

Low landing fees, VAT-free avgas and duty-free services make Alderney's airport - which has been operating since 1936 - a particularly attractive landing spot for private aviators.

Braye Harbour, the gateway to the Channel Islands and France, accommodates a passenger ferry from France and Guernsey and cargo vessels. The island is a popular first port of call which welcomes thousands of yachtsmen from all over Europe every year.

The capital of Alderney is the delightful town of St Anne. Its shops and various businesses cater for most modern-day needs and the island's many excellent restaurants offer value for money.

Leisure interests are well catered for with a number of clubs and societies. The island has a scenic, professionally maintained golf course and offers some of the finest sea-fishing in the Channel Islands. Surfing, tennis, horse riding, bowls and cricket are all popular pastimes.

The majority of Christian denominations are catered for on the island.

The currency is Sterling, with the States issuing, via the Royal Mint, a range of the island's own coinage, primarily for the numismatic market. Alderney also issues its own stamps which are produced by the Guernsey Post Office.

## An Introduction to Business and eCommerce

#### REGULATORY ENVIRONMENT

The Channel Islands are renowned for the stability of government and for the highest standards of regulation, accompanied by a sound judicial system. The island's government has introduced legislation to facilitate the development of eCommerce on the island and to support the electronic transactions of business, in straightforward, non-bureaucratic form, thus providing an ideal framework.

#### IN EUROPE, BUT OUTSIDE THE EU

The Bailiwick of Guernsey/Alderney is neither a member state nor an associate member of the European Union ("EU"). It has a special relationship with the EU which is set out in Protocol 3, based on Article 299(6)(c) of the European Treaty. The Island's constitutional position is laid down by Protocol 3 and cannot be changed unless that Protocol is changed by unanimous decision of all member states of the EU. Under the Protocol, Guernsey/Alderney is within the Common Customs Area and the Common External Tariff of the EU, allowing the free movement of goods within the Customs Union and the application of competition and state aid rules regarding trade in agriculture and fisheries products, as further specified in Regulation 706/73. The Island is not subject to EU provisions concerning the free movement of capital, persons and services although Protocol 3 prohibits the discrimination by the Island between nationals of EU Member States.

#### SIGNIFICANT TAX ADVANTAGES

- 0% standard tax rate on company profits from 2008 (10% on Banking activities, 20% on Utilities and 20% on Guernsey/Alderney property income)
- Low personal income tax (20%) and generous personal allowances on income of persons who live on the island
- No taxes on trusts whose beneficiaries live outside the island
- No Value Added Tax on goods imported from any EU country
- Professional advice is readily available from local accountancy practices who are also able to advise on setting up of Alderney-registered companies

#### **INFRASTRUCTURE**

Alderney has the perfect infrastructure to give small to medium sized businesses what they need and there is a natural fit with eCommerce companies and geographically portable businesses. The island's business environment, in particular its user-friendly company law, has been a key factor in the success of the island's eGaming industry which is world renowned. The island is also very close to the international offshore finance centres of Guernsey and Jersey so there is a tremendous amount of knowledge and expertise just a few miles away.

At present, the most common of eCommerce businesses found on Alderney are those associated with eGaming, many of which are back-office operations. However, there are a number of other entrepreneurial businesses operating on the island.

#### **BUSINESS SUPPORT**

Alderney's other major strengths lie in the presence of good business support. The island has no shortage of specialist legal, banking and accountancy expertise on hand and a sound system of company law is in place regulated by the Guernsey Financial Services Commission. In addition, company incorporation is not subject to unnecessary delays, set up costs are low and Alderney is in quick and easy reach of the other islands.

# A Guide to Alderney Companies

#### **USER FRIENDLY COMPANY LAW**

The Alderney Company Law was completely rewritten in 1994. The result is a modern, user-friendly piece of legislation that is ideally suited to today's eCommerce entrepreneurs.

In summary, the main features of The Companies (Alderney) Law 1994 are:

- Only one shareholder required
- Simplified filing procedures
- Unlimited 'Objects' clause
- Inherent Flexibility
- · Low setting up costs

A more detailed description is as follows:

#### THE COMPANIES (ALDERNEY) LAW 1994

The Companies (Alderney) Law 1994, came into force in mid-1995.

Its main features are:

- A minimum membership of one person
- Incorporation by registration
- Provision for the application of standard form articles if required
- Distinction between public and private companies
- Provision for companies limited by guarantee
- Provision for companies with a share capital and limited by guarantee ("Hybrid" companies)
- Provision for the adoption of pre-incorporation contracts
- Provision for share capital in any currency
- Issue of fractional shares and shares of no par value
- · Provision for redeemable shares
- Provision for purchase of own shares
- Simplified accounting records for private companies without the need to appoint an auditor
- Private companies may have a minimum of one director and a secretary

- Reduction of share capital subject to Court approval
- General meetings may be held anywhere and private companies may dispense with AGMs
- Provision for resolutions of members and directors in writing
- Modern provisions for amalgamations, arrangements, investigations and winding up

#### CONFIDENTIALITY

- Alderney companies are under the general supervision of the Bailiwick of Guernsey Financial Services Commission as well as the Alderney Registrar of Companies.
- The Commission receives details of the beneficial owners; this information is held in confidence and is not a matter of public record.
- The only information available to the public is that recorded on the Register of Companies which will include the memorandum and articles of association, the share capital, the names and addresses of the directors and registered shareholders, and particulars of any special resolutions.
- Anonymity may be increased through the use of local resident directors and nominee shareholders.
- The reason for confidential disclosure to the commission of the beneficial ownership of any new company is the exclusion of incorporation by persons who are known to have been involved in illegal or other undesirable activities.
- The disclosure requirement can usually be completed in a matter of hours and need have no serious effect on the time taken to incorporate.

# **Employment Permits**

#### **EMPLOYMENT**

For UK or EU citizens wishing to settle and work in Alderney, an Employment Permit system operates.

Anyone seeking gainful employment requires a work permit, although certain categories of employment are exempt.

Citizens of a non-EU country must apply to the Immigration and Nationality Department, Guernsey for a working visa and should check with their nearest British Embassy or High Commission.

#### APPLICATION PROCEDURE

Please use this document as **guidance only**. For full details please refer to the Employment Permits (Alderney) Law 1975, as amended:

# The procedure for potential employees is as follows:

- 1. You need to have been offered a job prior to applying for an Employment Permit.
- 2. If you have been offered a job, you will need to apply for an Employment Permit before you can take up any gainful employment. **Application forms for Employment Permits are available from the States General Office, The Island Hall, Alderney, GY9 3AA.**





# **Employment Permits**

- 3. The application form must be completed in full and countersigned by your employer. You will be required to disclose and give details of every offence of which you have ever been convicted, however minor, including traffic offences or offences committed whilst a juvenile. "Spent" convictions must also be shown.
- 4. Submit your application with the correct fee payable to the States General Office. Please note that you will be required to produce some form of photographic identification with a first application.
- 5. Your application will be processed by the States of Alderney who are empowered to grant or refuse an employment permit.
- 6. On average it takes between 7-14 days for the entire process to be completed, subject to all relevant papers having been submitted.
- 7. Under no circumstances should you commence any employment unless you are in possession of a valid employment permit.
- 8. Any change of job or additional job must be added to your employment record. A new form must be completed and signed by your new employer.

9. The States of Alderney has the right to revoke an employment permit if circumstances, which justified the grant or renewal of the permit, have been changed.

# **Property Market**

Alderney boasts a mature property market and is perhaps the easiest of the Channel Islands in which to purchase residential or commercial property. There are few restrictions on ownership of land or property, or the occupancy of existing dwellings.

Any citizen of a country within the European Union or Commonwealth can buy property in Alderney. Anyone who is not a subject of Her Majesty, or does not hold a Commonwealth or E.U. passport, at present by law, cannot purchase property unless permission is applied for and granted by the Court of Alderney and the Lieutenant Governor.







# The Government of Alderney

The Channel Islands are self-governing dependencies of the Crown, but they are not part of the United Kingdom, nor are they part of the European Union.

Alderney is a self-governing, democratic territory and one of the constitutive islands of the Bailiwick of Guernsey.

The United Kingdom looks after the Channel Islands in the fields of Foreign Affairs, Defence, Fisheries Protection and the islands' association with the European Union (EU).

The States of Alderney (the legislature) consists of a President and ten States Members. The President chairs the monthly meetings of the States and stands for election every four years. States Members also hold office for a period of four years and every two years there is an "Ordinary" election in which five of the sitting members offer themselves for re-election. Thus continuity at all levels is maintained and represents a stable, experienced parliamentary body.

Routine matters of Government are performed by three States Committees - Policy & Finance, General Services and Building & Development Control - which deal with all aspects of the island's finances, administration and future growth and expansion.

In addition, Alderney has two seats with voting rights on the States of Guernsey monthly Deliberation meetings. A small civil service team supports the elected Members to administer the island's affairs.

## **Taxation**

Alderney is part of the Bailiwick of Guernsey. The tax advantages of life in Alderney are:

- Low personal tax (20%) and generous personal allowances on income of persons who live in the island; and
- No Value Added Tax, Capital Gains Tax or Inheritance Taxes for domiciled residents.

Professional advice from a tax consultant familiar with Guernsey/Alderney tax laws is strongly recommended.

# Living and Working in Alderney

#### **Property Market**

Alderney boasts a mature property market and is perhaps the easiest of the Channel Islands in which to purchase residential or commercial property. There are few restrictions on ownership of land or property, or the occupancy of existing dwellings.

Any citizen of a country within the European Union or Commonwealth can buy property in Alderney. Anyone who is not a subject of Her Majesty, or does not hold a Commonwealth or E.U. passport, at present by law, cannot purchase property unless permission is applied for and granted by the Court of Alderney and the Lieutenant Governor.

#### Congé & Document Duty

On completion of a property purchase, the buyer is required to pay congé (similar to property tax) and document duty.

**The Congé** amounts to 2% of the realty price (i.e. bricks and mortar) and is payable to the States of Alderney.

**The Document Duty** is calculated on a sliding scale with the maximum amount of 3% being payable to the States of Guernsey.

**Registration Fee** is calculated at 0.05% of the realty price, with a minimum of \$50, and a maximum of \$400. This duty is payable to the States of Alderney.

**Estate Agency Commission** is payable by the vendor. For commission rates please contact the individual estate agencies.

#### Working in Alderney

For UK or EU citizens wishing to settle and work in Alderney, an Employment Permit system operates.

Anyone seeking gainful employment requires a work permit, although certain categories of employment are exempt. Citizens of a non-EU country must apply to the Immigration and Nationality Department, Guernsey for a working visa and should check with their nearest British Embassy or High Commission

# Medical and Health Care in Alderney

## Medical Care for Persons taking up Residence in Alderney

The island has two medical practices and a dental practice. The Mignot Memorial Hospital cares for the every-day health needs of island residents and specialist treatment can be obtained at the Princess Elizabeth Hospital in Guernsey.

There is no National Health Service as known in the UK. A free hospital accident and emergency service is available, but patients have to pay for ambulance services (annual subscriptions available) and for the service of the doctor in the Accident & Emergency Department. All GP's are in private practice and a fee is also payable for all consultations in the surgery or place of residence. Dentists, opticians, physiotherapists and chiropodists are also in private practice. Specialist cover provided under the compulsory Social Security Department Specialist Health Insurance Scheme covers the cost of specialist medical care provided by the Medical Specialist Group (MSG), which provides the emergency and elective specialist medical services for the Bailiwick of Guernsey. This scheme also funds physiotherapy provided by the Guernsey Physiotherapy Group when the referral is by a member of the MSG and medical treatment for acute care patients in the Mignot Memorial Hospital. For acute care patients there is no charge for radiology, pathology, medication and accommodation.

Charges are made for long stay patients and help is available through a means tested scheme if necessary.

Prescription medicines are available to residents on payment of a small prescription charge for each item which entitles the resident to a 28 day supply. A person over the age of 65 or in receipt of Supplementary Benefit is exempt from this payment and must sign the declaration on the back of the prescription.

Residents may also wish to contribute to private medical insurance schemes to cover General Practitioners fees.

There is currently no Reciprocal Health Agreement between the UK and the Bailiwick of Guernsey, therefore, residents wishing to visit the UK whether for business or personal reasons, will have to pay if they need healthcare whilst there. It is, therefore, essential that Alderney residents, and likewise visitors to Alderney, have full Medical & Travel Insurance for the duration of their visits and to ensure that their medical insurance policy does cover all eventualities.

# Social Security

## **Social Security Contributions**

Many people who move to Alderney are unaware of the social security liability which exists in Alderney. They may have come from territories where social security contributions are only required from persons who are employed or self employed, and where people who are not working may not be required to contribute or may only contribute on a voluntary basis.

Whilst liability for the payment of social security contributions as an employed person commences immediately, liability as a self-employed or non-employed person only commences after a person has been resident for a period of 26 weeks (not necessarily consecutively). After age 65 residents with income above a lower limit must pay specialist health insurance and long-term care contributions.

If you are about to take up employment in Alderney you must register at the Alderney States Office and obtain your social insurance card which you should hand to your employer.

#### **Social Insurance Benefits**

The payment of contributions provides for a range of social insurance benefits which are listed below:-

- Sickness Benefit
- Unemployment Benefit
- Invalidity Benefit
- Bereavement Benefits
- Death Grant
- Industrial Injuries Benefits
- Maternity Benefits
- Old Age Pension

Contributions paid under the United Kingdom social insurance scheme and some other countries may be taken into account by Guernsey to assist with entitlement to some of these benefits.

# Social Security

#### **Health Benefits**

Everyone who normally lives in Alderney and has been registered for the payment of contributions is covered. Children, including babies, are covered if they normally live in Alderney and at least one parent or other adult with whom the child normally lives is registered for the payment of contributions.

To be able to claim health benefit, every member of your household must have his or her own health benefit card. The benefits available are:

- Pharmaceutical Service
- Health Benefit Scheme
- Specialist Health Insurance Scheme

The Pharmaceutical Service provides prescription drugs and a limited range of medical appliances for a nominal prescription charge. The Health Benefit Scheme provides fixed rate grants towards the cost of medical consultations with General Practitioners and practice nurses. The Specialist Health Insurance Scheme provides free specialist medical care under four contracts which the States have with the medical specialist practices.

#### **Family Allowance**

An allowance is payable for every qualifying child of a family resident in Alderney. It must be claimed within 3 months of taking up residence or of the child's birth. All children under school leaving age qualify, as do any who are receiving a full-time recognised educational course until the 1st August following their 19th birthday. Families entering the island from the United Kingdom or Jersey are normally entitled to the allowance on taking up residence because of a reciprocal agreement between social security authorities. Agreements also exist with other countries but in the absence of any such provisions a qualifying period of residence of up to 12 months may have to be served before the allowance is payable.

#### **Attendance & Invalid Care Allowances**

These benefits are made available to residents who are severely disabled, physically or mentally and who need a lot of care by day or night.

#### **Travel Grants**

If medical treatment is not available in Alderney a resident person may be referred by their doctor for treatment in Guernsey or the UK. A travel grant scheme is available to assist with travel costs if you have registered for contribution purposes.

#### **Supplementary Benefit**

This is a means-tested benefit which is provided in order to bring people up to the level that the States consider to be the minimum amount required to live on.

## **Education Facilities**

#### **Education**

Alderney prides itself in an excellent educational system and the island's schools provide education from the age of 2 to 16. Class sizes in Alderney are considerably lower than other mainstream schools and children can benefit from more of a one to one teaching approach.

Alderney has several pre-school play groups where visiting children are welcome, and two principal schools: Ormer House, a fee-paying preparatory school and St. Anne's School, which provides free education.

Grammar School and College education (after the age of 11) and further education "A" levels etc, (after the age of 16) is provided in Guernsey.

#### **Ormer House Preparatory School**

A thriving co-educational preparatory school, Ormer House caters for children from the age of 2 years up to 13 years.

In order to enable the children to reach their full potential in every subject, class sizes are limited to an average of 12 pupils. The school curriculum is based firmly around the core subjects. A wide range of extra-curricular activities is offered and the school has an excellent record of success.

# **Imports and Licences**

#### **Importation of Animals**

You will require a licence to import:

- · Animals and Birds
- Cats and Dogs
- Endangered Species

Alderney is Rabies-free and only cats, other domestic animals and dogs(\*\*) originating from the British Isles or cleared through an authorised UK harbour may be landed in Alderney, once they have been cleared by the Alderney Customs Authorities.

However, under the recently-introduced Pet Travel Scheme, cats and dogs may also be imported from St.Malo, France - via Guernsey or Jersey - exclusively with Condor Ferries. Otherwise a 6-month quarantine applies.

Animals travelling from other countries require an import licence and may be subject to 6 months quarantine.

(\*\*) PLEASE NOTE: Pit Bull Terriers, Japanese Tosa or any other type of dog which appears to have been bred for fighting may not be imported.

# **Imports and Licences**

#### **Dog Licence**

All dogs over the age of six months must be registered with the States of Alderney. Licences are issued by the General Office and are renewable on 1st January annually.

A numbered disc is issued with the Licence. Dogs must wear a collar and disc at all times - replacement discs are available for a small fee.

PLEASE NOTE: Dogs are restricted from certain areas of the island at certain times of the year. A copy of The Dogs (Controlled Places) Ordinance 1989, as amended is available from the General Office. Please read carefully.

#### **Personal Effects**

Import duty is liable on goods imported from outside the European Union and is collected at a rate common to all twelve union countries. Excise duty, which applies to alcoholic beverages, tobacco products and motor fuel is set locally by the States of Guernsey.

Relief from payment of import duty on personal effects, household effects and motor vehicles may be obtained in certain circumstances.

In general terms, goods must have been in the importer's ownership and used abroad for at least six months.

#### Motor Vehicles, including Motor Cycles

#### **Import Permit:**

An Import Permit must be applied for before bringing a motor vehicle to the island. Any vehicle that arrives in Alderney without a Permit will be detained by Customs until an application form is completed, fee paid and Permit issued. Documentary evidence of un-laden weight is required. Please contact the States General Office for up-to-date information prior to application (Tel: +44 (0)1481 822811).

#### **Registering your Vehicle:**

If you intend to bring a car with you to the island then you will need to re-register it in Alderney within 14 days of arrival.

Before registering your vehicle you will need to provide a certificate, or, cover note of Third Party Insurance issued by a Guernsey authorised insurer and the original and current registration document for the vehicle from the country in which it is registered. If you do not have the registration documents, then, as an alternative, a Certificate of Permanent Export for the vehicle will suffice.

We are only able to accept original copies of the aforementioned paperwork. When you visit the General Office to register your vehicle you will be asked to complete an application form and pay a set fee. A further fee is due dependent on the actual un-laden weight of the vehicle. Vehicles will not be registered unless an import fee has been paid.

#### **Your Driving Licence:**

New residents are required to apply for a Guernsey Driving Licence **within one year** of arriving in the island. The States of Alderney are able to exchange full licences issued by many countries, including the United Kingdom and European Union members, for Guernsey licences provided that this is done within the one year period. Failure to do so may result in you having to take your driving test again. Please enquire at the States of Alderney General Office for further information.

PLEASE NOTE: Alderney has its own Traffic Regulations. Please request a free copy from the General Office. Whilst all car parking is free, Disc Parking Zones operate in some areas, including the Airport - parking discs can be obtained from the General Office. Please be sure to read the signs and set the parking disc accordingly.

\*Caravans, camper vans or dormobiles are not permitted on the island\*



# **Import Restrictions**

# Weapons, Explosives, Ammunition, Fireworks, Gas Canisters

#### DANGEROUS WEAPONS' LAW

The full law is available from the States Offices. This is a brief description of the items it covers.

This law makes it illegal to have in your possession or use "any weapon of any description designed or adapted for the discharge of any ammunition or for the discharge of any noxious liquid, gas or any other thing, and includes any component part of any such weapon and any accessory to any weapon designed or adapted to diminish the noise or flash caused by firing the weapon" unless you have a Weapons Certificate.

The definition of weapon includes shot guns, spear guns, catapults, bows, crossbows, ball bearing guns, air rifles, rifles and pistols.

The application forms for a Weapons Certificate are available from the States General Office and must be completed in full with an accurate description of the weapon(s) and ammunition to be purchased or in your possession.

If a weapon or ammunition is to be brought onto or exported off the island then an Import or Export licence is required. Application forms are available from the Chief Executive Officer's department.

All weapons' applications are referred to the police. The Chief Executive Officer has the right to refuse or revoke a Weapons Certificate if he believes the applicant to be under the age of eighteen years or unfit to hold a Weapons Certificate. There is an appeals procedure.

#### **DRUGS - WARNING!**

The possession or importation of any illegal substances are totally banned in all the Channel Islands and, irrespective of category, quantity, street value or personal circumstances, except if prescribed, may be punished with severe fines and in many cases carry a prison sentence.

# **Immigration**
