Forester Life Limited (Forester Life)**

NOTICE is hereby given pursuant to Section 45(3)(a) of the Insurance Business (Bailiwick of Guernsey) Law, 2002 that:

1. The Society and Forester Life intend to apply to the Royal Court of Guernsey (the **Royal Court**) for the sanction pursuant to Section 44 of the Insurance Business (Bailiwick of Guernsey) Law, 2002 by the Royal Court of a scheme (the **Scheme**) under which the whole of the long term insurance business of the Society in respect of Guernsey-resident policyholders is to be transferred to Forester Life (the **Transfer**).
2. The Society and Forester Life have made copies of:
 - (a) the proposed application; and
 - (b) the report of an independent actuary (the **Report**)

available for inspection (or for collection free of charge) at all reasonable times at the offices of Mourant Ozannes at the address given below up to and including the date of the court hearing. In addition, copies of the Report can be obtained free of charge from the website of the Society at www.thechildrensmutual.co.uk, by writing to the Society at Brockbourne House, 77 Mount Ephraim, Tunbridge Wells, Kent TN4 8GN (marked "Transfer proposal") or by telephoning our helpline number on 0845 6057001, from the date of publication of this notice until the date on which the Royal Court is asked to sanction the Scheme.

3. The application to sanction the Scheme is due to be heard by the Royal Court at The Royal Court House, St Peter Port, Guernsey on 22 March 2013 at 9.30am.
4. Any person (including any employee of any of the Society or Forester Life) who alleges that he would be adversely affected by the carrying out of the Scheme is entitled to be heard by the Royal Court. If you intend to appear at the hearing before the Royal Court, you are requested to give notice of your intention to do so to Mourant Ozannes no later than 19 March 2013, at the address given below.
