The Insurance Business (Bailiwick of Guernsey) Law, 2002

MetLife Limited (ML) MetLife Europe Limited (MEL)

NOTICE is hereby given pursuant to Section 44 of the Insurance Business (Bailiwick of Guernsey) Law, 2002 that:

1. ML and MEL intend to apply to the Royal Court of Guernsey (the **Royal Court**) for the sanction pursuant to Section 44 of the Insurance Business (Bailiwick of Guernsey) Law, 2002 by the Royal Court of Guernsey of a scheme (the **Scheme**) providing for the transfer to MEL of the entire long term insurance business of ML, including in respect of Guernsey-resident policyholders.
2. ML and MEL have made copies of:
 - a. the proposed application; and
 - b. the report of an independent actuary (the **Report**)

available for inspection (or for collection free of charge) at all reasonable times at the offices of Mourant Ozannes at the address given below up to and including the date of the court hearing. In addition, copies of the Report can be obtained free of charge from MetLife's UK website at www.metlife.co.uk/partvii, by writing to MetLife at Part VII Communications Manager, MetLife, Level 50, One Canada Square, London E14 5AA, or by telephone on 0808 1682499, until the date on which the Royal Court sanctions the Scheme as stated in paragraph 3 below.

3. The application to sanction the Scheme is due to be heard by the Royal Court at The Royal Court House, St Peter Port, Guernsey on 20 December 2013 at 9.30am.
4. Any person (including any employee of any of ML or MEL) who alleges that he would be adversely affected by the carrying out of the Scheme is entitled to be heard by the Royal Court. If you intend to appear at the hearing before the Royal Court, you are requested to give notice of your intention to do so to Mourant Ozannes by 13 December 2013, at the address given below.
