On 23 September 2014 the Royal Court of Jersey granted the application of PAL and PAC for the sanction of a scheme for the transfer of long term insurance business from PAL to PAC in respect of business carried on in or from within Jersey pursuant to Article 27 of and Schedule 2 to the Insurance Business (Jersey) Law 1996.

AND FURTHER TAKE NOTICE pursuant to Section 47(2)(b) of the Insurance Law that any policyholder who wishes to exercise any right that they may have to cancel a policy transferred by the scheme must do so within 21 days of the date of the publication of this notice.
