#### NOTICE

### **REGISTER OF BUILDING WORK**

The States of Alderney has appointed Hamon Architects to undertake a review of the Register of Building Works on Alderney, with the purpose of ensuring the Register is complete and up to date. In order to do this, from Monday June 15<sup>th</sup> they will be undertaking visits to all sites in order to ensure the Register is a current document. In addition they will also be assessing what stage each building project has reached in order for future building regulations approvals and inspections to be carried out.

Please note: this initial series of visits is purely to update the Register. No Building Control Inspections will be carried out during this process.

However, please take notice that Building Control Inspections will subsequently need to be carried out as a formal process. As from 10<sup>th</sup> February 2014 The Building (Alderney) Regulations 2014 came into force under which the Guernsey Technical Standards became the approved documents ensuring compliance with the those regulations. Due to a significant number of staffing changes within the States it has not been possible to undertake inspections to these standards, and the States is aware of the need for some guidance to be given to Contractors, Architects, Applicants and any others involved in any way with processes requiring Building Control Inspections.

These Building Control Inspections will be undertaken by the States' Appointed Inspector(s) and will also include guidance on how to achieve compliance with the 2014 Regulations. From 8<sup>th</sup> February 2016 onwards 2014 Regulations full compliance will be required.

The States appreciates that at this time not all parties involved in building processes will be fully 'up to speed' with the 2014 Regulations, and intends to run a series of workshops and seminars between 1<sup>st</sup> September 2015 and 5<sup>th</sup> February 2016 to clarify the 2014 Regulations requirements and work with those involved to enable future ongoing compliance to be achieved.

## THE BUILDING (ALDERNEY) REGULATIONS 2014

The Building (Alderney) Regulations 2014 were made law in Alderney in February 2014. The effect of these regulations is to bring the Island into line with building industry practice elsewhere in UK, Guernsey, Jersey and Europe by setting minimum standards of design and construction of domestic, commercial and industrial buildings. This requirement applies not only to new buildings but to the alteration of existing buildings and where the use of buildings changes.

This requirement is additional to the requirement to obtain Planning permission for any development. A separate application to the Building and Development Control Committee is legally required before carrying out any work to any property which falls within the scope of these building regulations which include:

Structure, Fire Safety, Site preparation, resistance to contaminants and moisture, toxic substances, resistance to the passage of sound, ventilation, health hygiene and water efficiency, drainage and waste disposal, heat producing appliances and fuel storage systems, safe means of access and egress, conservation of fuel and power, access to and use of buildings, glazing materials and protection, roads.

Copies of the Technical guidance documents which provide advice on meeting these regulations will be available for reference from the Planning office or from the States of Alderney website <a href="http://www.alderney.gov.gg/article/110203/Approved-Documents">http://www.alderney.gov.gg/article/110203/Approved-Documents</a> . This includes advice on the type of building work which is exempt from these regulations.
