The Insurance Business (Bailiwick of Guernsey) Law, 2002 (Insurance Law)

The Equitable Life Assurance Society (Transferor) Canada Life Limited (Transferee) (together, the Applicants)

The Applicants intend to apply to the Royal Court of Guernsey at The Royal Court House, St Peter Port, Guernsey (the **Royal Court**) on 12 February 2016 at 9:30 am for the sanction pursuant to Section 44 of the Insurance Law by the Royal Court of a scheme (the **Scheme**) providing for the transfer to the Transferee of certain long term insurance business of the Transferor, including in respect of Guernsey-resident policyholders and policies governed by Guernsey law.
