**42.1** Revive & Thrive – Recovery Strategy – Report from Chief Executive dated 18<sup>th</sup> June 2020 tabled and considered.

The Policy & Finance Committee resolved to note the publication of Revive and Thrive and request that the Committee for Tourism & Economic Development brings forward recommendations for further consideration seeking whatever collaboration is necessary with States of Guernsey. The Committee requested that the Alderney Representatives ensure that Alderney is recognised in any discussions in the States of Deliberation. A

letter of invitation to be sent to Deputy Gavin St Pier inviting him and other key politicians to Alderney in July for further discussions with this Committee.

**42.2** <u>Regeneration and Development Priority</u> – Report from Chief Executive dated 18<sup>th</sup> June 2020 tabled and considered.

The Policy & Finance Committee resolved to approve commissioning of research work and technical appraisals to improve the power infrastructure in the area between the Power Station, Fort Grosnez and the Harbour.

The Policy and Finance Committee agreed a budget provision of up to £50,000 from the Economic Development Reserve to fund this work.

**42.3** <u>Raz Blanchard Tidal Project</u> – Report from Alex Snowdon dated 16<sup>th</sup> June 2020 tabled and considered. Statement by Mr J Lancaster distributed for consideration.

The Policy & Finance Committee resolved to invite the Managing Director of AEL to be present at the next meeting of the Committee (via telecom) to update the Committee with the current situation regarding the Raz Blanchard project and clarify the issues raised in his paper to the committee.

**42.4** <u>Seaweed Revenue</u> – Report from Alex Snowdon dated 16<sup>th</sup> June 2020 tabled and considered.

The Policy & Finance Committee resolved to refer this report to the Committee for Tourism & Economic Development for further consideration.

The Policy and Finance Committee resolved that Alderney would not participate in the pilot test scheme and would await the results from that scheme before deciding on whether to participate in any future wider 7-day roll-out.

**43.2** <u>Alderney Campsite</u> Mr Harris advised on an email received from the Campsite warden seeking financial support for the 2020 season. The committee noted that information was still outstanding to support a decision.

The Policy and Finance Committee agreed to request relevant financial information to demonstrate need and evaluate this promptly with a view to making a decision by e mail on Monday 29<sup>th</sup> June.
