## 04/2020 Recreation, Welfare and Environment

### 4.1 Requests for Landlords Permission

a) Nunnery – Report from Chief Executive's Office dated 16<sup>th</sup> January 2019 tabled and noted.

The General Services Committee agreed to defer this item subject to further details with proposed costings. To be circulated via email for approval once received.

Email decision received on 28th January 2020.

The General Services Committee resolved (Mr Dean & Mr Gentle abstained) to grant landlords permission for the following:

- A new heritage site signage to be placed to the left of the main site gates. With the aim to provide an overview of the sites history and also encourage visitors to enter the site (within opening times) to discover more;
- To create a cobbled driveway with the aim to improve the appearance of the site's exterior. This driveway would hugely improve the uneven untidy current drive;
- 3. The Committee expressed concerns regarding the size of the wooden posts, and the cost.

The General Services Committee recommended that an alternative option be found, such as coping stones (similar to that on the target end on Longis) to compliment the surrounding area and possibly at a much reduced cost.

b) Alderney Wildlife Trust – Report from AWT dated December 2019 tabled and noted.

The General Services Committee agreed (Mr Dean & Mr Gentle abstained) to grant landlord's permission for the thinning of up to 10 non-native pine trees, and roughly half the oversized sycamores in the greenwood area for the purposes of establishing a coppice rotation.
