**78/2014** Minutes of the previous meeting of 14<sup>th</sup> October 2014, confidential minutes of the 7<sup>th</sup> October and special meetings of the 12<sup>th</sup> June and 18<sup>th</sup> September 2014 tabled and approved

#### 79/2014 Matters Arising

**79.1 St Anne's Church Progress Update** Report from Lovell Ozanne dated 5<sup>th</sup> November 2014 tabled and it was noted that the design of the scaffold to allow works on the tower is being reviewed as it will include rods which pass completely through the tower and thus internal consideration is required. **Noted** 

The Interim States Engineer was requested to enquire whether the fencing could be moved by 1 metre to allow better access for church attendees.

### **INTERIM ENGINEER**

<u>79.2 Coastal Protection – Corblets Wall</u> Further to the resolution by the Committee at the last meeting, the Interim States Engineer advised that he has discussed the matter with Royal Haskoning and has requested a scheme is produced by the end of this month for consideration by the Committee at the next meeting. **Noted** 

#### **INTERIM ENGINEER/AGENDA ITEM**

The Interim States Engineer advised that he has also requested the report on sea defences from Royal Haskoning, which had been part of their consultation earlier in the year. **Noted** 

Mr Roberts and Mr Tugby were not in favour of significant expenditure as they believed the works could be carried out at a reasonable cost using on island contractors and that the stone could be sourced on Island. The Interim States Engineer advised that due to the size of the stone required, on Island stocks would not be suitable. **Noted** 

**79.3** No 5 Connaught Square/Old Connaught Care Home Remedial Works Paper from the States Engineer dated 24<sup>th</sup> October 2014 tabled for ratification.

RESOLVED unanimously to agree to ratify the decision reached by email to approve the appointment of Island Construction to carry out the necessary repairs to the gable wall of 5 Connaught Square/Old Connaught Care Home for a sum no exceeding £5K through funding from the SWD Revenue budget (minor projects).

<u>79.4 No 5 Connaught Square/Old Connaught Care Home – Verbal Update</u> The Interim States Engineer advised that the remedial works being carried out on the old Connaught Care Home will resolve the issue of water ingress to No 5 Connaught Square.

<u>79.1.1 Clonque Road</u> The Interim States Engineer advised that there has been no response from the Landmark Trust with regards to the issue of coastal erosion threatening Clonque road. **Noted**

### 80/2014 Harbour and Fisheries

**80.1 Monthly Report** for October 2014 and Business Plan Progress Update tabled and the following was **noted**:-

- The serious electrical fault in the harbour area impacted operations for 8 days as there
  was also failure of the generator.
- The two outer sections of the dinghy pontoon along with the new landing section have been removed from the water for winter maintenance. The base and bridge section will be left in situ until renovation of the RNLI steps is completed.
- The annual Alderney Angling Festival welcomed 98 entries and it has been reported that it was very successful. Mrs Paris advised that she would be liaising with the Tourism and Marketing Department regarding the reported accommodation difficulties being highlighted for the 2015 event.

- **80.3 Pontoon Steps and Passenger Landing Improvement works** The Assistant Treasurer advised that total funding of £12,500 had been approved by T&R and works have commenced. **Noted**
