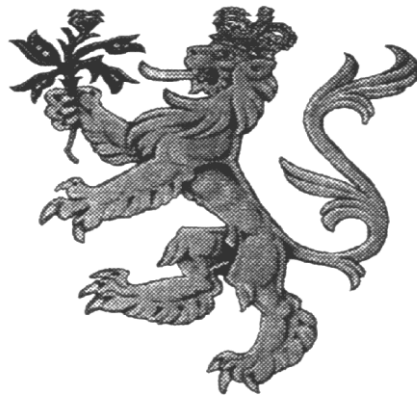

Item I **Public Holidays – Queen’s Diamond Jubilee**

The States resolved to approve “The Public Holidays (Alderney) (Queen’s Diamond Jubilee) Ordinance, 2011”.

Item II **Libya (Restrictive Measures) (Alderney) (Amendment) Ordinance, 2011**

The States resolved to approve “The Libya (Restrictive Measures) (Alderney) (Amendment) Ordinance, 2011”.

Proposed by Mr Beaman and seconded by Mr Kelly
Approved unanimously

Item III **Renewable Energy (Alderney) (Amendment) Law, 2011**

The States resolved to approve the Projet de Loi entitled the “Renewable Energy (Alderney) (Amendment) Law, 2011” and to request the President to seek the Sanction of Her Most Excellent Majesty in Council for it to have the force of Law in the Island of Alderney.

Approved unanimously

Item IV **Alderney Land Use Plan Review**

The States resolved to approve the alterations to the Land Use Plan, as proposed by the Building and Development Control Committee.

Approved by a majority, all in favour except Messrs Walden, Allen and Arditti who voted against.
