**The Insurance Business (Bailiwick of Guernsey) Law, 2002 (Insurance Law)**

**The Prudential Assurance Company Limited (Transferor)**

**Rothesay Life Plc (Transferee)**

**(together, the Applicants)**

On 14 June 2019 the Applicants applied to the Royal Court of Guernsey at The Royal Court House, St Peter Port, Guernsey (the **Royal Court**) for the sanction pursuant to Section 44 of the Insurance Law by the Royal Court of a scheme (the **Scheme**) providing for the transfer to the Transferee of certain of the long term insurance business of the Transferor, including in respect of certain Guernsey-resident policyholders.

The Applicants were granted leave to amend that application by the Royal Court on 29 November 2021. The resulting amended application (the **Amended Application**) for the sanction pursuant to Section 44 of the Insurance Law by the Royal Court of an amended version of the Scheme (the **Amended Scheme**) was subsequently heard by the Royal Court on 29 November 2021.

NOTICE is hereby given pursuant to section 47 of the Insurance Law that on 29 November 2021 the Royal Court of Guernsey granted the Amended Application of the Applicants for the sanction pursuant to sections 44 and 48 of the Insurance Law of the Amended Scheme for the transfer to the Transferee of certain long-term insurance business of the Transferor, including in respect of Guernsey-resident policyholders, and that any policyholder who wishes to exercise any right that they may have to cancel a policy transferred by the Amended Scheme must do so within 21 days of the above date of the Royal Court's order.
