# Job description

The post holder would be required to cover various roles with the Harbour Authority team including day to day boat and crane operations, maintenance duties and tasks and other duties required within the department. The post holder is expected to carry out duties to the required standards and in accordance with health and safety standards.

The post holder is ultimately responsible to the Harbour Master and in his absence the Deputy or Assistant Harbour Master.

# **Core Roles and Responsibilities**

- The day-to-day operation and maintenance of Harbour plant and machinery including the crane, tractor, boats and the Trailer Hoist.
- The out of season maintenance and refitting of all harbour moorings, pontoons and boats.
- The upkeep and repair of buildings and fixtures which reside within the harbour estate.
- The day-to-day maintenance and cleaning of all quays, buildings, slipways and services.
- To work within a roster for both boatman and crane driving operations.
- To meet, greet and assist visiting yachtsmen together with the collection of mooring dues during the spring and summer seasons.
- To crew the Pilot Boat during Pilot boarding operations and other Harbour duties.
- To carry out general maintenance of vehicles, plant, Harbour facilities and all other assets.
