**Item I**      **The Grant of Royal Assent to Projets de Loi, Counsellors of State and other Constitutional Matters**

The States of Alderney resolved, after consideration of the Policy Letter entitled 'The Grant of Royal Assent to Projets de Loi, Counsellors of State and other Constitutional Matters', that they are of the opinion:-

1. To agree that Royal Assent for Projets de Loi approved by a Bailiwick legislature may be granted by His Excellency the Lieutenant-Governor of the Bailiwick, on behalf of the King-in-Council (as set out in Section 7 of the Policy Letter).

2. **To direct the Policy & Finance Committee to liaise with the authorities in Guernsey and Sark (as necessary) on the practical and legislative arrangements that will be required to give effect to P1.**
3. **To acknowledge that the Counsellors of State Act 2022, regarding the addition of further Counsellors of State, has effect in Alderney (and the whole Bailiwick of Guernsey) by necessary implication.**
4. **To note the contents of the remainder of the Policy Letter.**
