22/2020 COVID 19

22.1 <u>Budget Implications</u> – Report from Treasury dated 20th April 2020 tabled and considered.

22.2 <u>Lockdown & Strategy to exit from Lockdown: Implications for Alderney</u> – Report from Chief Executive dated 19th April 2020 tabled and noted.

The Policy and Finance Committee thank Dr Nicola Brink for her excellent presentation on a Lock-Down Exit strategy (Sat 18th April) and supports that strategy. The Committee will from time-to-time consider the priorities for Alderney and will communicate those priorities to the CfHSC, CfHA and or CCA.
