78/2017 Matters Arising

70.1 <u>Committee feedback from Chairmen (B&DCC, GSC & Transport & Tourism) & Guernsey Representatives</u>

BDCC - The Committee noted a verbal update from the Deputy Chairman of BDCC, covering a range of matters including the LUP.

GSC – The Committee noted a verbal update from the Chairman of GSC, covering a range of matters including the Town Centre Traffic Survey, the breakwater, harbour fuel, sand extraction and lighting in the Airport car park.

Tourism – The Committee noted a verbal update from Tourism lead on various matters including Visit Guernsey being on island, the Fly-In and the Food Festival; and the greater use of social media advertising; and the opportunities to highlight Alderney's rich archaeological history given the recent Roman finds.

Guernsey Representatives – The Committee noted an update on the recent deliberations in respect of the 2016 Audited Accounts and the proposals for Island-wide voting. It was also agreed to explore in due course, the possibility of the Chairman of P&F or an equivalent representative having a seat on the Policy & resources Committee.

79/2017 <u>Digital Connectivity Update</u>

The Committee resolved to work with the two main telecom providers (Sure & JT) with a view to accelerating the delivery of Superfast Broadband services (both fixed line and mobile) to Alderney. The details of this to be worked out in due course, and following further liaison with the Telecoms and advice from the Chief Information Officer in Guernsey. It was also agreed to establish a 'Digital Economic Development Fund' and in due course to invite expressions of interest from telecommunications

firms (and others) to draw down that fund. This would require confirmation of criteria for accessing the fund based on:

- New employment opportunities;
- New taxation and other revenue opportunities;
- Reputational enhancements to Alderney as a business centre; and
- Enabling businesses that will lead to other new business opportunities.

It was further noted that the above expenditure would require States approval.

80.1 Air Links

80.1.1 **Aurigny**

The Committee noted a verbal update from the Chairman regarding updates on the progress of the Aurigny Review. The Committee also noted its serious concerns over the impacts on the economy and community of the recent disruptions to the air services.

80.2.1 MTWG Membership — Report from Deputy Chairman of General Services Committee dated 22nd June 2017.

The Committee agreed that:

- The Harbour Master be invited to advise the MTWG in advance of it holding any discussions with potential bidders for future Freight and/or Passenger Services; and that
- GSC be invited to nominate one member to be involved in the same process.

80.2.2 Freight Contract & Passenger Service

The Committee noted that expressions of interest were being sought in respect of a potentially joint Freight and Passenger Service to operate inter-island. It was also agreed to raise no objections to the General Services Committee simultaneously seeking tenders for the Guernsey/Alderney Freight Only contract. It further affirmed the need for GSC and P&F to work closely in respect of the Sea Transport Contracts.

81/2017 Legislation, Conventions & Policy

81.1 Tourism & Marketing Strategy Report – Report from TAG dated 20th June 2017 tabled and noted.

The Committee resolved to:-

- 1. Agree the paper which had been circulated and endorse its general principles;
- 2. Direct the Tourism Advisory Group (TAG) to continue its work to develop the ten year Tourism and Marketing Strategy, and to report back to P&F with progress in due course;
- 3. Direct TAG to restructure the 2018 tourism and marketing budget, for submission to P&F as part of the overall budget, in line with the recommendations in this paper; and
- 4. Approve in principle the following funding from the Economic Development Fund:-
 - a) Promotional Air Fares up to £150,000 (in 2018 potentially replacing underwriting additional rotations on GCI and SOU);
 - b) Passenger Ferry Subsidy up to £100,000 (already in EDF);
 - c) Protect our Product £40,000 already in EDF for 2018 and 2019 but broaden qualifying projects;
 - d) Resources £25,000 (one contract post for Visit Alderney to help with both the delivery of the tourism and marketing operations and strategy development) - £25,000 in each of 2018 and 2019
 - e) Digital marketing £30,000 in each of 2018 and 2019
 - f) New Route Programme £50,000 for new routes in each of 2018 and 2019 (already in EDP for assistance to Air Alderney £25,000 for 2017, £50,000 for 2018).
- Note that the total additional spend from EDF of £55,000 in each of 2018 and 2019 would be subject to approval by the States as part of the annual budget process.
