#### **Notice to Drone Users in Alderney**

The Civil Aviation & Aviation Security Regulator has commenced a period of consultation with relevant parties that would potentially be interested in the adoption of the UK CAA CAP 722 (Unmanned Aircraft System Operations in UK Airspace – Guidance) in the Channel Islands. In short, the current guidance previously issued by Guernsey Ports (<a href="www.airport.gg/drones">www.airport.gg/drones</a>) provides insufficient detail to provide adequate cover should an individual suffer death or life changing circumstances following a collision with a drone. All drone users in Alderney should be aware that currently if an individual wishes to fly a drone within 2 miles of Alderney airport they must seek permission from Alderney Air Traffic Control.

With the use of drones likely to increase in the near future e.g. estate agencies and building companies, the Civil Aviation & Aviation Security Regulators Office is prepared to coordinate the registration of all drone users in the Bailiwick. Permits would be issued to users, (in close liaison with both Guernsey and Alderney Air Traffic Control), with a small fee applied which would differentiate between commercial operators and those not making any gain. For commercial operators a permit would cost £82. For all other users of drones a basic registration fee of £9 valid for a year would be applicable.

In order to receive a permit, applicants must be able to evidence a level of competence together with sufficient record keeping i.e. flight logs and risk assessment in order to satisfy the Regulator that they are as safe as reasonably possible to operate such a system.

The ODCA holds the responsibility for all aviation safety, and security, matters, whether air space, aerodromes, air navigation services, air traffic services including licensing of controllers, as well as all aircraft operators — including UAS/Drones. The ODCA team monitor and assess applicants for all such aviation matters. In the past, an independent assessor, working on behalf of the ODCA, provided bi-annual audits of commercial UAS/Drone operators, typically at a cost to the operator of circa £450.

The Civil Aviation & Aviation Security Regulator is keen that Guernsey adopts this UK Guidance as secondary Bailiwick legislation, so that the Islands are in line with both the UK and EU regulations and continue to comply with the necessary aviation requirements.
