The following letter has been received from Mr Willmott, Chairman of the Policy and Finance Committee:-

"The prescribed fees of the above law have been reviewed on an annual basis since they were comprehensively reviewed in 2007 following an interval of several years. Although any revised fees are not effective until the following calendar year, fees are now reviewed earlier in the year in order to allow maximum notice for Company Administrators.

Sections 159 and 164 of The Companies (Alderney) Law 1994 deal with fees and any changes thereto. Section 159 is the section dealing with general fees. Section 164 gives the States the power to make Ordinances to amend certain fees elsewhere in the law and not covered by Section 159. The tables below highlight the current fees, together with the proposed fees which have been increased by RPIX at 2.4% (rounded), as recommended by the Company Registrar and subsequently agreed by the Policy and Finance Committee.

<u>Item IV</u> <u>Plebiscite for the Alderney Representatives in the States of Deliberation, Guernsey – deferred from 22 September 2010</u>

The following letter has been received from the President:-

"On the 18th October 2006, the States resolved, as a pilot experiment, to hold a plebiscite for the appointment of the Alderney Representatives to sit in the States of Deliberations, Guernsey. This pilot was successful, the public were consulted in May 2007 and there was support for this procedure to continue.

The States of Guernsey (Representatives of Alderney) Law 1978 states that the Alderney Representatives must be appointed every year at the annual meeting. The States of Alderney resolved at the October 2006 meeting that the result of the plebiscite would be confirmed for a period of two years. That period will expire at the end of 2010.

Therefore, at the annual meeting in January 2011, the States will be required to appoint two representatives and two alternative representatives to sit in the States of Deliberation. The plebiscite allows for the wishes of the electorate to determine who represents them in the States of Deliberation. It is therefore proposed that a plebiscite takes place to ascertain theses wishes.

In order to hold the plebiscite and give effect to its outcome, the States proposes:

- 1. To conduct a plebiscite of the electorate on Saturday 11th December 2010 to determine whom the electorate wish to represent them in Guernsey.
- 2. The candidates will be any States Member who states that they wish to serve as a Representative. The list of candidates will be published by 1st December 2010. (States membership for 2011 and 2012 will have been decided by the States election on 27th November 2010).
- 3. The voting process will be similar to that of a States Election and will take place in the Members Room, Island Hall from 9:30 a.m. to 6:30 p.m.
- 4. Each voter will be asked to place a cross against the names of the two candidates they wish to support. Only two choices will be allowed, any ballot paper with more than two X's will be disqualified.
- 5. The Jurats will be asked to count the votes.
- 6. The States commits itself to elect as its Representatives, at the Annual Meeting in January, the two Members with the most votes. The two Members that poll the third and fourth highest number of votes will be elected as the Alternate Representatives. As the Law requires that our representatives are elected annually, those successful in this ballot will be re-elected in 2012.
- 7. In the event of a tie between two or three Members, the States will choose the Member with the longest previous service as a States Member. Should neither have had any previous States experience or both have equal experience; the States will make the choice. In the unlikely event of only three Members receiving any support, the States will choose the fourth.
- Information will be available to the electorate on this process prior to the 11th December 2010

<u>Item VII</u> <u>Alderney Land Use Plan Enquiry</u> (see attachment 2)

The following letter has been received from Mr Sargent, Chairman of the Building and Development Control Committee:-

"Under the terms of the Building & Development Control (Alderney) Law, 2002, as amended, where the Building & Development Control Committee is disposed to approve an application for permission to carry out any development or work involving a departure from a Land Use Plan, or where re-zoning is required to facilitate utilities' operational development, the Committee may request the President of the States to appoint an Inspector to hold a Planning Inquiry. Mr Anthony Whitehead, Dip TP, MRTPI was appointed on 7th July 2010 as Inspector to consider proposals for alteration to and addition to the Alderney Land Use Plan and to hear any representations or objections made or offered thereto.

The Inquiry was held over a 2 day period on the 10th and 11th of August 2010 and the scope of the Inquiry was to consider 5 proposed alterations and additions to the LUP for the island.

The statutory background for the Review and procedures derives from Part IV of the Building and Development Control (Alderney) Law, 2002.

I attach a copy of the Inspector's Report (dated 31st August 2010). The Committee has given this full consideration and, as required by section 29 of the Law, now lays the Report before the States, and asks that the States approve the Inspector's recommendations.

I shall be obliged if you place this matter before the States at its next meeting with an appropriate proposition.

The States is asked to approve the following alterations to the Land Use Plan:-

 Land adjacent to Rue de La Saline & Le Petit Val (Zone 14A) – Proposed subdivision into two separate zones, to enable the development of the western side of the Zone to proceed.

The States is asked to approve the proposed modification of the LUP Key Map by the creation of Zones 14A and 14, as shown on the attached plan.

2. Land at Butes Field / York Hill (Zone 4) - Proposed re-zoning to enable certain commercial activity, if essential to a community scheme's funding and development.

The States is asked to accept the Inspector's recommendation that the alteration for Zone 4 as submitted to the Inquiry be withdrawn and not proceeded with.

3. Grand Hotel Site, Butes (Zone 2A) – Proposed re-zoning to facilitate higher density development.

The States is asked to approve the modification of the LUP policy for Zone 2A to: -

"This area is reserved for residential development including social housing. Consideration should be given to the effect of any proposal on the skyline.

An overall development plan for the whole site will need to be approved prior to consideration of any application for development.

The overall development plan and individual plans for new dwellings should demonstrate that the proposed development fits in with the topography of the site and its surround and include landscape proposals for the finished project.

Applications for new development must fall within applicable defined policy guidelines for this zone.

Reason: To make the most efficient use of the limited land resources available in this key location."

4. Land adjacent to Battery Quarry / Rue de Beaumont – Proposed re-zoning to Public Utility Zone for future essential development by the Alderney Water Board.

The States is asked to approve the re-zoning of land at Battery Quarry / Rue de Beaumont from Agricultural to Public Utility Zone as shown on the attached plan.

5. Land off Windy Corner, La Marette – Proposed re-zoning to Public Utility Zone for construction of a water storage facility by the Alderney Water Board.

The States is asked to approve the re-zoning of land at Windy Corner, La Marette from Agricultural to Public Utility Zone, as shown on the attached plan, and to take into account the Inspector's recommendation that the site be reduced in area to enable a suitable landscaping area to be created outside the zone at the easterly end of the site.

<u>Registration of Buildings and Conservation Areas under the Building and Development Control (Alderney) Law, 2002.</u>

<u>Item IX</u> Alderney Gambling Control Commission: Appointment of Commissioner

The following letter has been received from Mr Willmott, Chairman of the Policy and Finance Committee:-

"At its meeting held on 27th September 2010 the Policy and Finance Committee considered the recruitment of a new Gambling Control Commissioner following the departure of John Clitheroe in June 2010. With the Commission now comprising only three commissioners the Policy and Finance Committee has decided to recommend the appointment of Mr Jeremy Thompson as a further Commissioner. The appointment is for a period of five years in the first instance (which may be extended).

The position was advertised locally, in Guernsey and Jersey and in the United Kingdom and interviews were conducted in Alderney. Account was not only taken of the strength of individual experience and qualifications of those interviewed but also of the balance of these, having regard to the expertise of the existing Commissioners, required to meet the needs of the Commission in the immediate and medium term future of the Commission. Mr Thompson's experience in the telecommunications industry was considered to provide that balance.

The approval of the States to the appointment of Mr Thompson as a Member of the Commission is sought in accordance with the provisions of the Gambling (Alderney)

Law, 1999. I would be obliged if this is placed before the States at its next meeting together with an appropriate proposition.

<u>Item X</u> <u>Budgets for 2011 and Expected Outturn 2010</u> (see attachment 3)

The following letter has been received from Mr Willmott, Chairman of the Policy and Finance Committee:-

"As required by section 58 of the Government of Alderney Law, I enclose the budget estimates of income and expenditure for 2011 and the expected outturn for 2010.

The main aim of the annual budget is to ensure that adequate funds are available to meet the revenue costs of the various public services and the capital expenditure requirements. The Law requires the States to consider the budgets and directs that thereafter they should be forwarded to the States of Guernsey.

The States receives an annual revenue cash allocation from the States of Guernsey, which, together with the States own income, makes it necessary to prioritise the areas of public services that can be provided from the finite resources available. Annual budgets provide a framework, they do not bind the States to spend in any particular area and nor do they preclude the States from choosing to vary the levels and standards of service it provides. Nonetheless, the figures given in the budget are clear indicators of expected income and expenditure in the various sectors.

In preparation of the annual budgets, Committees have had to consider:-

- a) Is the service necessary and appropriate in the present economic situation?
- b) Is there an alternative, more efficient, way of providing the service?
- c) Are charges and fees adequate & when were they last reviewed?

Revenue Account - Expected Outturn 2010

Under the financial procedures, the revenue cash allocation from Guernsey for 2010 was set at £1,600,000. It was also agreed that in order to meet the shortfall created by loss of rental income on the expected formation of the Alderney Housing Association that the £200,000 annual capital allocation could be transferred to the revenue account, which in the event was not required due to delays in the formation of the Association. This then left a balance of £76,600 to be met from Alderney's accumulated unspent balances, which at 1st January 2010 amounted to £116,330. However in March it was agreed that the remainder of the unspent balances should be put towards the roads resurfacing budget in order to enable Ronez to carry out a full program of works during the year.

Revenue Account - Budget Estimates for 2011

The Treasury and Resources Department of the States of Guernsey has set the revenue cash allocation for 2011 at £1,615,000. In addition a submission was made to Treasury & Resources under the States Strategic Plan for £165,000 additional

funding in respect of States properties in order to redress the net loss of annual rental income which will be experienced on the formation of the Alderney Housing Association. A similar bid was made in 2009, however once again the submission to Guernsey was not considered a high priority item in the list of essential service developments recommended by the Policy Council, therefore requiring the £200,000 capital allocation to be transferred to the revenue account again for 2011 in order to cover this initiative, and other areas of increased expenditure.

As mentioned above the unspent balances are now exhausted which has placed additional pressure to balance within the budget for 2011, and future years. Individual managers have therefore been given greater responsibility, and accountability, for their departmental budgets. Ongoing reviews of expenditure and income will be required to ensure we remain within budget, including a review of States operations. However, some of our major items of income, for example the numismatic royalties, philatelic income, bank interest etc, depend almost entirely on factors outside our control. The current global financial situation is likely to have a further adverse effect on these sources, as has already been apparent over the last two years.

The main items within the revenue budget for highlighting include :-

Occupiers Rates - The Policy & Finance Committee has agreed not to increase the Occupier's Rate in order to give ratepayers some reprieve in 2011 taking into account the 10% Water Rate increases which have been necessary annually since 2006. The matter of the introduction of a payment of a different rate, by those non-residents who do not pay tax to Guernsey, has been under discussion for some time. It was agreed by the Policy and Finance in April 2010 that it wished to proceed with a policy based on granting rebates to full time resident taxpayers and the Law Officers have been requested to draft appropriate legislation, including making Occupiers Rates payable by the owners of properties for consideration by the States. It is likely that this will be brought forward next year but naturally will depend on the then States to make a final decision.

<u>Salaries</u>, <u>Wages and Pensions</u> - In the budgets of each department the costs of salaries, wages, employer's pension and Social Security contributions are combined into the heading of "Staff". There were no increases in salaries and wages in the 2010 pay awards, and no increase in staff numbers. In 2011 we have been advised to allow 1.5% increase for Established Staff, with the Public Service Employees award still to be negotiated.

As reported to the States in December 2009, a review of the States Pension Scheme is currently underway, and it is hoped to report back to the States before the end of the year. The Pension fund deficit is a problem that will require further difficult decisions to be made. Guernsey has similar difficulties with its own pension fund and Alderney is maintaining close contact with Guernsey so that any significant changes to pension arrangements in both Islands are made at the same time. In the meantime Alderney will continue to make changes that it considers essential to prevent the deficit escalating further.

Refuse Collection, Separation and Disposal – The 2011 budget for waste disposal has once again been limited to £500,000, with all aspects of waste disposal under continual review. This is the largest item of States expenditure and it is a credit to all those involved that for the fourth year running we are able to set this target of no increased expenditure. All residents have a part to play in this and it is only by continuing to recycle a larger proportion of our waste that we can further reduce the cost of managing the Island's waste.

<u>Harbour Budget</u> – The revised method of charging in relation to hydrocarbons, coupled with additional shipping movements which have been made possible by the

larger Commercial Quay, will produce a surplus on the Harbour account in 2010, with a reduced deficit budgeted for 2011.

Capital Account 2010 & 2011

Capital income and expenditure, as with the revenue account, has been subject to a small cash allocation from Guernsey. As explained earlier in the report this allocation is now available to subsidise the revenue account. With effect from 2004 the monies raised from Congé and other property transfer duties are retained by Alderney as capital income. The slump in the housing market in the UK has had a knock on effect in Alderney, as receipts from Congé in 2010 continue to reduce compared to previous years, and it is difficult to forecast any improvement in 2011. The 2010 figures represent a 66% reduction on 2007 figures. The figures contained on pages 10 to 12 reflect the actual and budgeted amounts charged to the accounts in each year for capital projects and do not include the opening balances of funds available.

It is now policy that Alderney Gambling Control Commission surpluses should be used to fund items on Alderney's capital programme. The annual surplus from AGCC is expected to reduce in 2010 to £1.1m, with £1.6m expected for 2011. These reserves together with income from Congé and some property sales, will be used to finance the majority of the capital programme.

The Commercial Quay Project is now nearing completion, and despite early delays construction of the New Connaught Care Home is well underway, with an expected completion date of Spring 2011.

An up to date summary of the States capital income and expenditure forecast, and the annual balances on the capital allocation account, for the next four years is attached as Appendix 1 for information purposes.

Going forwards the Policy & Finance Committee has agreed that the priority capital projects for 2011 should be the Water Board Phase 3 relating to storage facilities, together with a new sewerage main from Mouriaux to Platte Saline.

Work has commenced on a new strategic plan, an update of the Island Plan, which a small P&F subcommittee has been working on for some time. It is anticipated that a draft plan will be available for the new States to discuss, amend and approve early in their term of office.

It is important to recognise that the approval by the States of the overall Capital Budgets does not mean that any individual project can proceed without further approval under the financial procedures. The Capital Budgets are therefore to be seen as an indication of probable projects, rather than a firm schedule.

Water Board

The estimates for the Water Board show an operating surplus on the Revenue account of £33,300 in 2010. This is an improvement over the past two years, directly brought about by recent increases in charges, together with wage recoveries attributable to the capital projects

In 2011 the deficit on the revenue account is predicted at £75,350, which is mainly attributable to depreciation and increase in fuel and electricity costs associated with the capital projects, together with an extensive maintenance schedule shown under mains & machinery. The 2011 income allows for a further increase in rates with effect from quarter 3, which will be necessary to meet the increasing operating costs. The Water Board is taking a longer term view of the need to maintain a positive balance between operating revenues and costs and is conscious of the need to keep

increases in the current economic climate to the minimum. Nevertheless the significant improvements in both the supply of water and its quality do not come at nil cost and these ultimately have to be borne by consumers.

As the Water Board has no capital funds of its own available for the projected improvements to the water treatment plant and distribution system it has been agreed that these should be financed by capital grants from the States of Alderney. The first phase, the new transfer main and collection points between Bonne Terre and Battery Quarry, costing £349,000 is now completed and Phase 2, relating to centralised filtration costing £700,000, is due to be installed in November. As mentioned earlier the next phase relating to storage facilities will be forwarded to the States for debate in due course.

These budgets have been considered and approved by Guernsey's Treasury and Resources Department, and will appear in summary format as part of the Guernsey budget later this year.

Once again I would like to thank the Treasurer and her staff for the efficient and courteous manner in which they have supported a wide range of States activities during the year, of which the Budget preparation is one small part

I would be grateful if you would lay this matter before the States with appropriate propositions.
