50% of Fees will be reimbursed on the permanent export of the vehicle from the island within 2 years starting from the date it was imported; unless permanent export takes place within 28 days of importation, when 100% of Fees will be reimbursed, less an administration charge of £40.

This came into effect as of 1st January 2019 – ref The Fees (Alderney) Ordinance, 2018.
